1. **SWEEPSTAKES DESCRIPTION:** The **BODYARMOR® Fall Football National Sweepstakes** (“**Sweepstakes**”) begins on 8/1/23 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 11/1/23 at 11:59:59 PM ET (the “**Sweepstakes Period**”). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of BA Sports Nutrition, LLC, 17-20 Whitestone Expressway, Suite #401, Whitestone, NY 11357 (“**Sponsor**”), which shall be final and binding in all respects. 2. **ELIGIBILITY:** Open to legal United States residents residing in the fifty (50) United States and District of Columbia who are eighteen (18) years of age or older.
